*The test mixture for Total PFAS is made up of PFOA (500 ppt), PFOS (1,000 ppt), PFHxS (300 ppt), PFNA (50 ppt), PFHpA (40 ppt), PFBS (260 ppt), and PFDA (10 ppt). This system meets the 20 ppt requirement for Total PFAS.
